Explanation You are required to complete this form if you wish to take part-time retirement. The Pension Fund must be in possession of the duly completed form no later than 2 months prior to the date on which you wish to take part-time retirement.

I wish to take part-time retirement from day - month - year (date)

My part-time percentage will then be 80% 60% 50%

I wish to receive a temporary pension to the amount of up to the age of 65

I intend to take partial retirement in respect of the hours that I will no longer be working.

Explanation In consultation with your employer, you may take partial retirement from the age of 55. Here you indicate the date from which you wish to take part-time retirement and the percentage at which you wish to continue working (your part-time percentage). If you take part-time retirement before your official retirement age, the amount of your annual retirement pension will be lower. The partner's pension will also be lower as a consequence.

In addition to your part-time pension, you can also request a temporary pension up to the age of 65. According to fiscal regulations, your temporary pension may not exceed the AOW benefit for a married couple, multiplied by your part-time retirement percentage. Each year as from 1st July, the Pension Fund adjusts this maximum.

If you take partial retirement, you will no longer be working for that part of your time. This also means that you will no longer accrue any pension entitlements for that part of your time. Once you have taken part-time retirement, your part-time work percentage cannot be increased again. You can decrease this however, to a minimum of 50%.

Explanation You and your partner must both always sign this form. Please send the duly completed and signed form to your HR department. This department arranges for a statement of consent from your employing company and then forwards the form to the Pension Fund. You will receive a confirmation from the Pension Fund.

Please submit the form in good time

The Pension Fund must be in possession of this form no later than 2 months prior to the date on which you wish to take part-time retirement. If the Pension Fund does not receive your form on time, the commencement date of your part-time retirement is postponed automatically. On receipt of your form, the minimum notification period of 2 months must first have expired, after which your part-time retirement commences on the first day of the following month. You will receive a confirmation from the Pension Fund indicating the date on which your part-time pension commences.
